UPON AN APPLICATION for leave of the Court to commence an application for judicial review of the decision of the Inland Enforcement Officer with the Canada Border Services Agency dated May 21, 2015;

AND UPON READING the material filed;

THIS COURT ORDERS that:

1. Leave is granted and the application for judicial review is deemed to have been commenced.

2. The hearing of the application for judicial review is hereby fixed for Wednesday December 16, 2015, to commence at 9:30 a.m., at the Federal Court, 180 Queen Street West, in the City of Toronto, in the Province of Ontario, for a duration not exceeding two (2) hours.
3. The hearing shall be conducted in the English language, unless counsel for either party notifies the Registry of the Court otherwise.
4. The Tribunal shall send certified copies of its record to the parties and to the Registry of the Court on or before October 15, 2015, unless it has already done so.
5. Further affidavits, if any, shall be served and filed by the Applicant on or before October 23, 2015.
6. Further affidavits, if any, shall be served and filed by the Respondent on or before November 3, 2015.
7. Cross-examinations on affidavits, if any, shall be completed on or before November 13, 2015.
8. The Applicant's further memorandum of argument, if any, shall be served and filed on or before November 23, 2015.
9. The Respondent's further memorandum of argument, if any, shall be served and filed on or before December 3, 2015.
10. The transcript of cross-examinations on affidavits, if any, shall be filed on or before December 3, 2015.
